- I acknowledge and accept that I may lose access to external dispute resolution services;
- I acknowledge and accept that I may receive marketing material about wholesale product offers e.g. IPOs, access to equity placements, etc. and understand I can opt-out at any time by calling CommSec. I also understand and accept that by opting out, I will be opting out of the Sophisticated Investor Program;
