Note:

- ASX Rules relating to FOR Securities require the owner of those securities to assess whether they are a 'Foreign Person' according to the relevant issuing company's definition, and to advise their sponsoring broker of the owner's personal classification for each security.
- 'Foreign Person' definitions are provided by every issuer of FOR Securities and they differ from one security to another. For example, an owner may be a 'Foreign Person' based on the definition set by one issuing company, but may not meet the definition set by another issuing company. If you do not meet the 'Foreign Person' definition, you are considered to be a 'Domestic' investor.
- It is important you correctly classify the residency status of the beneficial owner of all FOR Securities in accordance with the issuing company's definition to ensure that the issuing company can accurately monitor its compliance with any foreign ownership restrictions that might apply to each security. Where there is more than one beneficial owner, if one or more beneficial holders on your account meet the Issuing Companies 'foreign' holder definition, then the residency classification for the account should be confirmed as 'foreign'.
- Where you confirm to us a residency status that is different to your existing residency status, we may update the residency status on your HIN with CHESS, or open a second account for you with the different residency status.
